Subject: Launching of DDA Sabka Ghar Awaas Yojana 2025 with special discount of 25% in the Flats for different disadvantaged sections of society for ensuring accessibility to affordable housing.

The Delhi Development Authority (DDA) is pleased to announce launching of DDA Sabka Ghar Awaas Yojana 2025 with a special **25% discount** on **EWS, LIG, MIG, and HIG** flats at various locations in Narela, Loknayakpuram, and Siraspur. This offer is available on a **limited inventory** of flats and the discount will be **valid only until 31.03.2025** and will be available on a First Come First Serve (FCFS) basis (Pehle Aao, Pehle Pao). This initiative aims to ensure greater accessibility to affordable housing for various disadvantaged sections of society.

Discounts on Flats:

- **EWS and LIG Flats at Loknayakpuram, Siraspur, and Narela**
- **MIG and HIG Flats at Loknayakpuram and Narela**

Eligibility Criteria:
